Lechowicz moved, with Byard supporting, to approve the bid. All yes. Cease moved, with Byard supporting, to have Lechowicz mow at the township hall for \$45 per mow. Byard, Cease, Holt and Prout voted yes. Lechowicz abstained. The light on the flag at the cemetery has been replaced and the water is turned on. Two small additional areas are being opened for lots. Two quotes were received for markers. Lechowicz moved, with Cease supporting, to approve the bid from American Cemetery Supplies. All yes. There is a headstone placed in the wrong spot. The township will move it to the correct area. The center road has serious ruts. There was discussion about filling them. Lechowicz will bring more information. Lechowicz moved, with Holt supporting, to charge \$475 for full burials to be distributed as follows: \$425 for opening and closing, \$25 for marking and \$25 administrative. All yes.
- II. L-4029 Lechowicz moved, with Cease supporting, to approve the 2023 Tax Rate Request. The millage to be levied is 0.9906 for Allocated and 0.9906 for Additional Allocated. All yes.
